**IMRE KIFOR’S RENEWED MOTION TO INVESTIGATE “MENTAL HEALTH”
MADNESS, FRAUD ON THE COURT, AND INSTITUTIONALIZED CHILD ABUSE
(FORCED PARENTAL ALIENATION)**

NOW COMES the Plaintiff/Defendant, Imre Kifor (“Father”), and respectfully states:

1. Since the start in 2011, Father has consistently requested this Court to order investigations into the fraudulently fabricated and purely activist “high conflict” aspects of these matters.
2. Father has repeatedly filed timely pleadings substantiating the deliberately allowed and feminist-driven “mental health” madness, systemic Rule 60 fraud on the court, and sustained institutionalized child abuse, specifically, **the state-subsidized forced parental alienation**.
3. Most recently, Father submitted his meticulously documented Refiled Motions For Relief Pursuant To Rule 60 Fraud On The Court (on 8/8/2023), Twice-Refiled Amended Complaints For Modifications Pursuant To Employment Discrimination And Racketeering (RICO) Statutes (on 9/6/2023), and Renewed Motions For Summary Judgment (on 10/9/2023).
4. This Court has not communicated any decisions regarding Father’s proper and timely filings.

5. Custody matters cannot be resolved with summary judgments. Therefore, Father respectfully requests that this Court appoint qualified Guardian Ad Litem (with a sworn “do no harm” medical degree, and not just a repeat of the same **corrupt activists** as mere “psychologists”) to review the parallel matters. Father also asserts that he is not able to pay for any services.
6. Alternatively, this Court could allow Father to subpoena the medical and therapy records of his children and call them as witnesses to testify against their loving parent in court (see the attached ruthlessly brainwashed "**You were born and taught with malicious [Romanian] manners and you had tried to teach me when you were younger**" emailed cruel remark).
7. Since the last judgments issued in the matters, Father has learned that the two mothers of his four children have engaged in sustained malicious defamation, Rule 60 Fraud On The Court, conspiracy to silence and enslave, and stereotypical statutory discrimination against Father.
8. Father has substantiated his allegations with a Civil RICO Class Action Complaint filed in the U.S. District Court and a Petition For Writ Of Certiorari filed in the U.S. Supreme Court.
9. Father has also filed Complaints For Protection From Abuse (G.L.c. 209A) with this Court.
10. To support his claims of deliberate and ruthless child abuse, Father attaches his Affidavit On Sustained Institutionalized Child Abuse (Forced Parental Alienation) with exhibits.

WHEREFORE, Father respectfully requests this Court to order proper investigations into the feminist-driven “mental health” madness, systemic Rule 60 fraud on the court, and sustained institutionalized child abuse (specifically the forced and state-subsidized parental alienation).

**IMRE KIFOR'S AFFIDAVIT ON SUSTAINED INSTITUTIONALIZED CHILD ABUSE
(FORCED PARENTAL ALIENATION)**

NOW COMES Imre Kifor ("Father"), and respectfully states:

1. Father is an engineer. He designed and developed a software product by himself. He received a \$10M offer for it in 1999. At the time, [REDACTED] ("Mother-B") and Father lived together in Reading. In a rage, Mother B attacked him with a **knife** for refusing the offer.
2. Weeks later, Father received a different offer for \$25M that he accepted and later shared with Mother-B, just as he had promised her. The newly multi-millionaire Mother-B then engaged in a high-profile divorce from her first husband. While living in Harvard, Mother-B acquired a gun license. Father witnessed Mother-B practicing and "shooting" her ex-husband "**dead.**"
3. On 4/28/2011, Mother-B deliberately **lied** to the police and DCF about materially significant aspects of her preemptively staged "coup" to wrestle custody of children away from Father.
4. Mother-B doubled down on the systemic and sustained child-predatory fraud when aiding and abetting this Court to unjustly a) handcuff Father - on 6/6/2019, b) order him to jail - on 10/21/2019, and c) arrest him again - on 1/21/2022. Mother-B also continued to **conspire** with [REDACTED] ("Mother-C") in the deliberate effort to defame Father with purpose-fabricated "mental health" projections and national-origin-based "official" discriminations.


5. Specifically, Mother-C maliciously **lied** to the police on 1/1/2009 only to conceal her prior physical assault on Father and his children. Just days later, Mother-C pled the fifth in court.
6. Mother-B and Mother-C colluded later to discredit and also reframe the reports of Mother-C threatening a child with a knife and incessantly beating her older son. Effectively, Mother-B and Mother-C acted together to force this Court to falsely accuse Father of committing **rape**.
7. Manifestly disregarding the best interest of the children, this Court decided to stereotypically fault Father (despite the meticulously filed prior evidence) when the GALs unambiguously reported that “Mother-B either lacks affect or was bullied to abandon her twins.”
8. Therefore, in a systemic and sustained effort to deliberately silence and enslave Father, this Court has repeatedly rejected his evidence, even regarding his supervised visitations (the 14 monitors never complained about his 500+ visits with his four children) by denying the sole trial exhibit about Father having to end the supervised visits to protect his **crying children**.
9. This Court has resorted to deliberately and systemically violating Father’s constitutional rights only to prevent him from calling his Harvard Medical School psychiatrist witnesses.
10. Specifically, the preeminent Dr. Alexandra Harrison, MD, characterized Mother-B and Mother-C as “**very dangerous borderlines, you have no idea what they are capable of.**”
11. Father has now substantiated his allegations of a systemic and sustained conspiracy to silence and enslave, while deliberately abusing innocent children, to the U.S. District Court, 1:23-cv-12692, the U.S. Court of Appeals, 23-1008, and also the U.S. Supreme Court, 23-5932.
12. The text of Father’s signed *pro se* motions, complaints, and petitions to the above federal courts is hereby attached and fully incorporated herein as Father’s supporting affidavits.
